ADJUSTMENTS TO THE STANDARD CHART OF ACCOUNTS (SCOA)

PURPOSE

1. The purpose of this document is to inform all government financial practitioners of the upcoming late changes to Infrastructure segment for the chart of account to be implemented **01 April 2017**. These changes are unavoidable and the Committee would like to apologize for the inconvenience this will cause as this will result in delays in finalizing the budgets of the departments in the financial systems (BAS).

DISCUSSION

2. The chart of account to be implemented 01 April 2017 has been designed to be able to facilitate the category links between the Infrastructure, Asset and Item Segment. This was done so in order to eliminate the inconsistencies as a result of the incorrect combination. It is therefore very important that we ensure that the system will be able to achieve this by ensuring that the number of combination options available to the users are limited.
3. During the testing of the category combinations it was established that there is still chances of inconsistencies due to the availability of the multiple options to the users. This is illustrated by the combination in table 1.1. The changes as captured in table 1.2 were proposed and implemented to ensure that the category links would at best eliminate chances on inconsistencies when transacting on the system.
4. The Classification Circular together with the publication of the Chart of Accounts (excel version) will be issued separately, in the same manner as they have always been issued on the SCOA website. This document is a notice to inform departments of the planned change to be made on the Chart of Accounts as well as the financial system (BAS). At the time of writing this notice some of the codes were not created as new category links still needed to be created in the background table. Once created departments will be informed accordingly.
